

Pacific City Dorymen's Association Memorial Wall

Individual Names Criteria

Amended 05/21/2018

- *Nominations will be presented in writing to a member of the Memorial Wall Committee to be considered for inclusion on The Memorial Wall.*
- *Written nominations will explain why an individual should be considered for inclusion on the Memorial Wall stating what criteria the individual has met and any other special reasons that should be considered.*
 - *A representative of the Memorial Wall Committee will notify the Board of Directors that they have been presented with an individual name & who that individual is.*
 - *The Memorial Wall Committee will discuss and review the merits of a nominee and then forward the nominee's written nomination to the Board of Directors.*
- *At its discretion, written nominations will be discussed at a quorum of the Board of Directors during any scheduled spring board meeting for consideration and voted on at the next fall board meeting.*
 - *The person making the nomination can make a personal presentation to the Board of Directors along with their written nomination but may not be present when nominee is discussed or voted on.*
- *For nominations that are not approved by the Board of Directors, a simple statement will be given to the person nominating the individual for inclusion, stating that the nomination was not approved. All discussions about the individual or the vote count are confidential.*
- *Nominations that are approved by the Board of Directors will be presented to the full membership at either the spring or fall membership meeting, discussed by the membership and voted on.*

- *The person making the nomination can make a personal presentation to the membership but may not be present when nominee is discussed or voted on.*
- *The vote for inclusion/exclusion by the membership will be done by secret ballot.*
- *The vote will be counted by 2 members of the Board of Directors.*
- *After the votes are tallied, the count will be presented to a Chairman of the Board. The Chair will announce to the membership that the nomination has either been accepted or rejected by the membership. The vote count will be confidential.*
- *If the nomination fails to get a majority of votes from the Board of Directors or the membership, the individual nomination can be considered again the next time the Board of Directors considers nominations.*
- *For nominations that are not approved by the membership, a simple statement will be given to the person nominating the individual for inclusion, stating that the nomination was not approved.*
- *The Board of Directors will determine how many names will be added to the Memorial Wall each year.*
- *To consider an individual's name for inclusion on the Memorial Wall this individual should have had an extraordinary positive impact on the dory fleet. The following criteria may be used to help determine this person's impact.*
 - *This individual must be deceased.*
 - *This individual perished while aboard a traditional dory participating in traditional dory activities.*
 - *This individual must have repeatedly sailed from Cape Kiwanda through the surf to the sea between 1930 and the present in a traditional single or double-ended dory.*

- *This individual has actively promoted Pacific City and Cape Kiwanda as "The Home of The Dory Fleet".*
- *This individual has been an advocate of commercial and sport fishing on the Oregon coast.*
- *This individual has gone above or beyond the call of duty to defend the Dorymen's way of life and heritage, through political and cultural means.*
- *This individual has supported Pacific City and the Pacific City Dorymen's Association.*
- *This individual has helped a fellow doryman in life-threatening peril or desperate need.*
- *This individual was a dory boat builder (either single or double-ender).*
- *This individual was a fish buyer who bought dory caught fish.*
- *This individual was a dory marine mechanic or dory boat repairman.*
- *This individual was a fish seller who sold dory caught raw fish to the public, or sold cooked dory caught fish in a restaurant.*
- *The final question to consider for all individuals involved in the nominating or voting process is the following.*
 - *Was this person a real doryman or dorywomen who believed in our traditions and way of life?*
